- Title bolded and centered incorrectly
- No header
- Paragraphs not indented
- Wrong citation: ("Smith pg. 22")
- Works Cited not alphabetized

2.3 BEFORE/AFTER — Chicago Example Template

Before

- Missing footnotes
- In-text citation instead of footnote
- Bibliography missing publisher location
- Title italicized incorrectly

After

- Footnote inserted:
 - 1. Author, Title (City: Publisher, Year), Page.
- Bibliography corrected

Explanations

• Chicago Notes-Bibliography relies on footnotes instead of in-text citations.
