PAPER FORMAT

Margins: 1 inch on all sides

Font: Readable font throughout (Times New Roman 12pt, Arial 11pt, Calibri 11pt, Georgia 11pt, or Lucida Sans Unicode 10pt)

Line Spacing: Double-space entire paper, including title page, abstract, body, and references

Paragraph Indentation: Indent first line of each paragraph 0.5 inches

Page Numbers: Top right corner of every page, including title page

Alignment: Left-align text (ragged right margin)

PAPER STRUCTURE

Title Page (Page 1)

• Title (bold, centered, middle of page)

- Author name(s)
- Institutional affiliation
- Course number and name
- Instructor name
- Assignment due date
- Page number (top right)

Abstract (Page 2) - If required

- Heading "Abstract" (bold, centered)
- 150-250 words
- Single paragraph, not indented
- Keywords (optional): Indented, italicized "Keywords:" followed by 3-5 keywords

Body (Page 3 onward)

- Title (bold, centered at top)
- Introduction (no heading needed)
- Main sections with appropriate headings

References (New page)

- Heading "References" (bold, centered)
- Hanging indent (0.5 inches)
- Alphabetical order by author surname

• Double-spaced

HEADINGS

Level 1: Centered, Bold, Title Case Level 2: Flush Left, Bold, Title Case Level 3: Flush Left, Bold Italic, Title Case Level 4: Indented, Bold, Title Case, Ending With a Period. Text begins on same line. Level 5: Indented, Bold Italic, Title Case, Ending With a Period. Text begins on same line.

IN-TEXT CITATIONS

Parenthetical Citations

One author: (Smith, 2020)

Two authors: (Smith & Jones, 2020)

Three or more authors: (Smith et al., 2020)

Group author (first citation): (American Psychological Association [APA],

2020)

Group author (subsequent): (APA, 2020)

No author: ("Title of Work," 2020) or (Title of Work, 2020) for long titles

No date: (Smith, n.d.)

Direct quote: (Smith, 2020, p. 15) or (Smith, 2020, pp. 15-16)

Multiple works: (Jones, 2019; Smith, 2020)

Narrative Citations

One author: Smith (2020) found...

Two authors: Smith and Jones (2020) discovered...

Three or more: Smith et al. (2020) reported...

Direct quote: Smith (2020) stated, "quote" (p. 15).

REFERENCE LIST ENTRIES

Books

Basic format: Author, A. A., & Author, B. B. (Year). *Title of book: Subtitle* (Edition). Publisher.

Example: Brown, L. S. (2018). Feminist therapy (2nd ed.). American Psychological Association.

Edited book: Editor, A. A. (Ed.). (Year). Title of book. Publisher.

Chapter in edited book: Author, A. A. (Year). Title of chapter. In E. E. Editor (Ed.), *Title of book* (pp. xx-xx). Publisher.

Journal Articles

Basic format: Author, A. A., Author, B. B., & Author, C. C. (Year). Title of article. *Title of Journal, Volume*(Issue), page range. https://doi.org/xxxxx

Example: Smith, J. D. (2020). The effects of mindfulness meditation. *Journal of Psychology*, 45(3), 234-256. https://doi.org/10.1037/xxxxx

Article without DOI: Include URL if accessed online

8+ authors: Include first 19 authors, then ellipsis (...), then final author

Websites

Webpage with author: Author, A. A. (Year, Month Day). *Title of webpage*. Site Name. URL

Webpage without author: Title of webpage. (Year, Month Day). Site Name. URL

Webpage without date: Author, A. A. (n.d.). *Title of webpage*. Site Name. URL

Other Sources

Newspaper article: Author, A. A. (Year, Month Day). Title of article. *Newspaper Name*. URL

Magazine article: Author, A. A. (Year, Month Day). Title of article. *Magazine Name*. URL

YouTube video: Author, A. A. [Username]. (Year, Month Day). *Title of video* [Video]. YouTube. URL

Podcast: Host, A. A. (Host). (Year, Month Day). Episode title (No. episode number) [Audio podcast episode]. In *Podcast name*. Production Company. URL

Social media post: Author, A. A. [@username]. (Year, Month Day). First 20 words of post [Description of audiovisuals]. Platform. URL

Conference paper: Presenter, A. A. (Year, Month Day-Day). *Title of contribution*. Conference Name, Location. URL

Dissertation/Thesis: Author, A. A. (Year). *Title of dissertation* [Doctoral dissertation, Institution Name]. Database or Archive. URL

Government report: Agency Name. (Year). *Title of report* (Report No. xxx). URL

Dataset: Author, A. A. (Year). *Title of dataset* (Version number) [Data set]. Publisher. https://doi.org/xxxxx

TABLES AND FIGURES

Tables

Numbering: Number consecutively (Table 1, Table 2)

Title: Italic, below table number

Format: - Table number (bold) - Table title (italic, title case) - Table body - Note (if needed): *Note*. Explanation of table content

Figures

Numbering: Number consecutively (Figure 1, Figure 2)

Title: Italic, below figure number

Format: - Figure number (bold) - Figure title (italic, title case) - Figure image - Note (if needed): *Note*. Explanation of figure

ABBREVIATIONS

First use: Full term followed by abbreviation in parentheses Example: American Psychological Association (APA)

Subsequent uses: Use abbreviation only (APA)

Latin abbreviations (use only in parentheses): - e.g., (for example) - i.e., (that is) - etc. (and so forth) - vs. (versus) - et al. (and others)

In narrative text: Use English equivalents (for example, that is)

NUMBERS

Use numerals for: - Numbers 10 and above - Numbers below 10 used with units of measurement (5 cm, 3 years) - Numbers in the abstract - Statistical or mathematical functions - Numbers that precede a unit of time (3-year-olds) - Exact sums of money (\$5) - Numerals as numerals (the number 7)

Use words for: - Numbers below 10 not described above - Numbers that begin a sentence - Common fractions (one third) - Universally accepted phrases (Twelve Apostles)

PUNCTUATION WITH CITATIONS

Comma: Separate author and year (Smith, 2020)

Ampersand (&): Use in parenthetical citations (Smith & Jones, 2020)

"And": Use in narrative citations: Smith and Jones (2020)

Semicolon: Separate multiple citations (Jones, 2019; Smith, 2020)

Period: Place after parenthetical citation at end of sentence.

Exception: Direct quotes - period comes after citation (Smith, 2020, p. 5).

COMMON MISTAKES TO AVOID

1. Using running head on student papers (no longer required)

- 2. Using "Retrieved from" before URLs (only needed if date-sensitive content)
- 3. Incorrect hanging indent in references
- 4. Missing DOI or URL in references
- 5. Inconsistent heading levels
- 6. Single-spacing references
- 7. Using footnotes for citations (use in-text citations)
- 8. Not capitalizing proper nouns in article/chapter titles
- 9. Italicizing journal article titles (only journal name should be italicized)
- 10. Including database name in reference (not needed unless work is difficult to locate)
