Margins: 1 inch on all sides

Font: Readable, legible font (Times New Roman 12pt recommended)

Line Spacing: Double-space entire paper, including heading, title, body text, block quotes, and Works Cited

block quotes, and works Cited

Paragraph Indentation: Indent first line of each paragraph 0.5 inches (one

Page Numbers: Last name and page number in upper right corner of every

Alignment: Left-align text throughout

File Format: Save as .docx or .doc (unless instructor specifies otherwise)

## PAPER STRUCTURE

First Page Header

**Upper left corner (double-spaced):** - Your Name - Instructor's Name - Course Name and Number - Date (Day Month Year format: 5 November 2025)

**Title:** - Centered on next line after date - Standard capitalization (capitalize first word and all major words) - Not bolded, underlined, or italicized (unless title includes another title)

Body: - Begin text on line after title - Double-spaced throughout

### Works Cited Page

- Begins on new page after essay ends
- Heading "Works Cited" centered at top
- Entries in alphabetical order by author's last name
- Hanging indent (0.5 inches)
- Double-spaced throughout

## IN-TEXT CITATIONS

#### **Basic Format**

Author's name in signal phrase: Smith argues that "quotation" (15).

**Author's name in parentheses:** The evidence suggests that "quotation" (Smith 15).

Two authors: (Smith and Jones 42) OR Smith and Jones argue that...

Three or more authors: (Smith et al. 78) OR Smith et al. found that...

Corporate/Organization author: (American Red Cross 25)

No author (use shortened title): ("Global Warming" 34) OR ("Article Title" 12)

Multiple works by same author: (Smith, Book Title 45) OR (Smith, "Article Title" 12)

Multiple authors with same last name: (John Smith 23) and (Mary Smith 45)

Indirect source (citing someone quoted in your source): (qtd. in Smith 67)

Multiple works in one citation: (Smith 15; Jones 42; Brown 88)

### **Special Cases**

No page numbers (online sources): (Smith) - Use author name only

Numbered paragraphs or sections: (Smith, par. 4) OR (Smith, sec. 2)

Time stamps (audio/video): (Smith 00:12:35-41) OR (00:12:35-41) if no author

Scripture: (Bible, John 3:16) - Book, chapter:verse

Shakespeare/Classic works: (Shakespeare, Hamlet 3.2.118-20) - Act. Scene. Lines

Entire work: Smith discusses... [No page number needed]

Block quotes (4+ lines of prose or 3+ lines of verse): - Indent entire quote 0.5 inches - No quotation marks - Citation after final punctuation - Double-spaced

Example: Smith makes this important observation: This is a long quote that continues for several lines and demonstrates the hanging indent format that should be used for block quotations in MLA style. (42)

## WORKS CITED - CORE ELEMENTS

MLA 9 uses a flexible template with 9 core elements:

- 1. Author
- 2. Title of source
- 3. Title of container (larger work)
- 4. Other contributors
- 5. Version
- 6. Number
- 7. Publisher
- 8. Publication date
- 9. Location

**Format:** Each element is followed by the punctuation shown: Author. Title. Container, Contributors, Version, Number, Publisher, Date, Location.

# WORKS CITED ENTRIES

#### Books

One author: Smith, John. Title of Book. Publisher, Year.

Two authors: Smith, John, and Mary Jones. Title of Book. Publisher, Year.

Three or more authors: Smith, John, et al. Title of Book. Publisher, Year.

Editor as author: Smith, John, editor. Title of Book. Publisher, Year.

Chapter or essay in edited book: Brown, Lisa. "Chapter Title." *Title of Book*, edited by John Smith, Publisher, Year, pp. 45-67.

E-book: Smith, John. Title of Book. E-book ed., Publisher, Year.

**E-book with URL/DOI:** Smith, John. *Title of Book.* Publisher, Year. *Database Name*, doi:xxxxx.

**Translated book:** Author, First. *Title.* Translated by Translator Name, Publisher, Year.

Edition other than first: Smith, John. *Title of Book*. 3rd ed., Publisher, Year.

Multivolume work: Smith, John. Title of Book. Vol. 2, Publisher, Year.

### Periodicals (Journals, Magazines, Newspapers)

**Journal article (print):** Smith, John. "Article Title." *Journal Name*, vol. 45, no. 3, Year, pp. 234-56.

Journal article (online database): Smith, John. "Article Title." Journal Name, vol. 45, no. 3, Year, pp. 234-56. Database Name, doi:xxxxx.

Journal article (website with DOI): Smith, John. "Article Title." Journal Name, vol. 45, no. 3, Year, pp. 234-56, doi:xxxxx.

Magazine article (print): Smith, John. "Article Title." Magazine Name, Day Month Year, pp. 42-48.

Magazine article (online): Smith, John. "Article Title." Magazine Name, Day Month Year, www.website.com/article.

Newspaper article (print): Smith, John. "Article Title." Newspaper Name, Day Month Year, pp. A1+.

Newspaper article (online): Smith, John. "Article Title." Newspaper Name, Day Month Year, www.newspaper.com/article.

Article with no author: "Article Title." Publication Name, Date, Location.

### Websites

Entire website: Website Name. Publisher, Year, www.website.com.

**Page on website:** Author Last Name, First Name. "Title of Page." Website Name, Publisher, Day Month Year, www.website.com/page.

Website with no author: "Title of Page." Website Name, Publisher, Date, URL.

Website with no date: Author. "Title of Page." Website Name, Publisher, Accessed Day Month Year, URL.

Website with no publisher: Author. "Title of Page." Website Name, Date, URL.

### **Digital Sources**

YouTube video: Author/Username. "Title of Video." YouTube, uploaded by Username, Day Month Year, www.youtube.com/watch?v=xxxxx.

**Podcast:** Host Last Name, First Name, host. "Episode Title." *Podcast Name*, season number, episode number, Publisher, Day Month Year, URL.

**Tweet:** @Username (Real Name). "Full text of tweet." *Twitter*, Day Month Year, Time, URL.

**Instagram post:** @Username. "Caption text or description of post." *Instagram*, Day Month Year, URL.

**Facebook post:** Author Name. "Full text of post." *Facebook*, Day Month Year, URL.

**Email:** Smith, John. "Subject Line." Received by Mary Jones, Day Month Year.

**Online forum post:** Username. "Title of Post or First Few Words." *Forum Name*, Day Month Year, URL.

#### **Multimedia Sources**

**Film:** *Title of Film.* Directed by First Last Name, performances by First Last Name and First Last Name, Studio, Year.

**TV episode:** "Episode Title." *Series Name*, season number, episode number, Network, Day Month Year.

**TV episode (streaming):** "Episode Title." *Series Name*, created by Name, season number, episode number, Production Company, Year. *Streaming Service*, URL.

Music album: Artist. Album Title. Label, Year.

**Song:** Artist. "Song Title." *Album Title*, Label, Year, streaming service or URL.

**Personal photograph:** Photographer Last Name, First Name. *Title or Description*. Year. Medium.

**Artwork:** Artist Last Name, First Name. *Title of Artwork*. Year, Institution/Collection, City.

Interview (personal): Interviewee Last Name, First Name. Personal interview. Day Month Year.

Interview (published): Interviewee. "Interview Title." Interview by Interviewer Name. *Publication*, Date, Location.

## Other Sources

Government document: Government Agency. *Title of Document*. Publisher, Year, URL.

**Dissertation (published):** Author. *Title.* Year. University, PhD dissertation. *Database*, URL.

**Dissertation (unpublished):** Author. *Title.* Year. University, PhD dissertation.

Conference paper: Author. "Title of Paper." Conference Name, Day Month Year, Location.

**Lecture or speech:** Speaker. "Title of Lecture." Sponsoring Organization, Day Month Year, Location.

**Advertisement:** Company Name. Advertisement. *Publication*, Date, Page or URL.

**Review:** Reviewer. "Title of Review." Review of *Title of Work*, by Author Name. *Publication*, Date, Location.

## **QUOTATIONS**

Short Quotations (fewer than 4 lines of prose or 3 lines of verse)

Integrate into text with quotation marks: Smith argues that "direct quotation here" (45).

**Punctuation:** - Place periods and commas inside quotation marks - Place colons and semicolons outside quotation marks - Place question marks and exclamation points inside if part of quote, outside if not

### Block Quotations (4+ lines of prose or 3+ lines of verse)

**Format:** - Start on new line - Indent entire quote 0.5 inches - No quotation marks - Double-space - Citation after ending punctuation

Example: According to Smith: This is a block quotation that extends for more than three lines and should be formatted with a hanging indent and no quotation marks around it. (42)

### Poetry

**3 or fewer lines:** Use slash (/) with space before and after to show line breaks Example: In the poem, the speaker states, "Line one / Line two / Line three" (1-3).

4+ lines: Use block format, maintaining original line breaks

### FORMATTING TITLES

Italics (for longer, stand-alone works):

• Books: The Great Gatsby

- Journals/Magazines: The New YorkerNewspapers: The New York Times
- Websites: WikipediaFilms: Inception
- TV series: Breaking BadAlbums: Abbey Road
- Plays: Hamlet
- Ships/Aircraft: Titanic

## Quotation Marks (for shorter works, parts of larger works):

- Articles: "Title of Article"
- Book chapters: "Chapter Title"
- Short stories: "The Lottery"
- Poems: "The Road Not Taken"
- Essays: "Self-Reliance"
- TV episodes: "Pilot"
- Songs: "Hey Jude"
- Web pages: "About Us"

## No Italics or Quotation Marks:

- Sacred texts: the Bible, the Quran, the Torah
- Legal documents: the Constitution, the Bill of Rights
- Your own paper's title (at top of first page)

## **CAPITALIZATION**

In Titles (Title Case): - Capitalize first and last words - Capitalize all major words (nouns, verbs, adjectives, adverbs, pronouns) - Lowercase articles (a, an, the) - Lowercase prepositions (of, in, to, for, with, etc.) - Lowercase coordinating conjunctions (and, but, or, nor, for, so, yet)

**Example:** The Catcher in the Rye

**In Sentences:** - Capitalize first word after colon if it begins a complete sentence - Capitalize proper nouns and adjectives derived from proper nouns

## **ABBREVIATIONS**

Common abbreviations in MLA: - ed. = edition or edited by - eds. = editors - et al. = and others (use for 3+ authors) - n.d. = no date - n.p. = no publisher - p. = page (rarely used in MLA 9) - pp. = pages (use for page ranges in Works Cited) - par. = paragraph - qtd. in = quoted in - sec. = section - vol. = volume - no. = number

Months (in Works Cited): Abbreviate months longer than 4 letters: Jan., Feb., Mar., Apr., May, June, July, Aug., Sept., Oct., Nov., Dec.

Time: Use a.m. and p.m. (lowercase with periods)

### **NUMBERS**

**Spell out:** - Numbers that can be written in one or two words (twenty, forty-five, one hundred) - Numbers that begin sentences

Use numerals for: - Numbers that require more than two words (101, 1,275) - Dates, addresses, exact sums of money - Page numbers, volume numbers, act/scene/line numbers - Percentages, decimals, statistics - Time with a.m. or p.m. (8:00 a.m.)

**Special cases:** - Large numbers: use combination (4.5 million) - Inclusive page numbers:  $45-48,\ 120-25,\ 1365-401$  - Ranges: use en dash (2020-2021) or hyphen (45-48)

## PUNCTUATION WITH QUOTATIONS

**Periods and commas:** Always inside quotation marks "Quote," Smith argues (15). Smith argues, "Quote" (15).

Colons and semicolons: Always outside quotation marks Smith discusses "the problem"; however, Jones disagrees (22).

**Question marks and exclamation points:** - Inside if part of quoted material: Smith asks, "Why?" (15). - Outside if part of your sentence: What does Smith mean by "the issue" (15)?

Ellipsis (...): Use to show omitted words from quotation "The beginning ... and the end" (Smith 15).

**Brackets** []: Use to add clarifying information or change capitalization "She [the author] argues that..." (Smith 15). "[T]he evidence shows..." (Smith 15).

## COMMON MISTAKES TO AVOID

- 1. Using "Works Cited" as a header with page number (should be centered title)
- 2. Forgetting hanging indent on Works Cited entries
- 3. Including URLs that are too long (use permalink or DOI when available)
- 4. Not alphabetizing Works Cited entries
- 5. Using first names first in Works Cited (always: Last name, First name)
- 6. Including access dates for stable sources (only for undated sources)
- 7. Underlining titles instead of italicizing
- 8. Single-spacing any part of the paper
- 9. Using "pg." or "page" before page numbers in citations
- 10. Forgetting to cite paraphrased information
- 11. Including retrieval statements ("Retrieved from") unless needed for unstable content
- 12. Using footnotes or endnotes for citations (use in-text parenthetical citations)

**Key changes in MLA 9:** - Simplified URL formatting (use permalinks, remove "https://") - Greater flexibility with source types - Updated guidance on social media citations - New examples for contemporary digital sources - Streamlined treatment of online sources
